The medieval alpine town of **Zell am See** is one of the most beautiful places in Austria, picturesquely situated between Lake Zell and the **Schmittenhöhe** mountain and ski area. A couple of miles up the road is the sleepy little village of **Kaprun**, which lies at the foot of the well-developed glacier ski area of Kitzsteinhorn and the towering Kitzsteinhorn peak. While these two ski areas are not interconnected, they are very closely situated and both covered under the Europa Sport Region Ski Pass. Zell am See is the gateway to Austria's highest peak, the Grossglockner and Kaprun has the largest glacier in Austria.

4* Hotel zum Hirschen is located in the pedestrian zone of Zell am See, only a 2-minute walk from the lake. It offers award-winning cuisine and free Wi-Fi access. A rich breakfast buffet with many regional products is served in the morning. Half-board includes dinner with a salad buffet. The restaurant was awarded one toque by Gault Millau. The spa area features a sauna, an infrared cabin, Kneipp baths, a dive pool, and a relaxation room. Massages and beauty treatments can be booked at the reception. A massage room is available.



On the way home, spend two nights in **Prague**—one of the World's last great Imperial cities. Seemingly timeless in architecture and culture, this city never ceases to amaze. Visit the famous castles or spend your time in the Old City wandering the cavernous streets and alleyways. Its traditional pubs and eateries have been augmented by a wave of gourmet restaurants, cocktail bars and trendy cafes - though you can still feast on pork and dumplings washed down with a beer... A perfect end to a fabulous European adventure!
